
Balanced: The fund portfolio is suitable for clients seeking a balanced portfolio with relative risk.

Investment Objective

This portfolio gives equal priority to security and returns. It invests extensively in funds in which the bulk of the assets held consist of fixed-interest securities. These are combined with higher-risk funds in a balanced ratio.

The portfolio is actively managed on the basis of a professional top-down approach and undergoes continuous monitoring. Temporary controlled deviations from the investment strategy are permitted, depending on the market situation. All funds are selected according to YOUPLUS's tried-and-tested 4P fund selection process, which ensures that only the best fund managers in a given asset class are included in our fund portfolios.




